1. In response to a recent request from BOB for the assignment of a large number of accommodation addresses, we have assigned the following CABATONS to BOB:

With the exception of CABATON 31 who was assigned to ACOMPASS (who communicated from the West) for a brief time, all the above are fresh, previously unused addresses.

2. With regard to CABATONS 41, 42, and 43, we wish to emphasize that these three are unwitting drops recruited by CABATON 38 (formerly CAEDITOR 1) on a personal basis. They have been led to believe that they are receiving personal mail for CABATON 38 from the DDR because the latter fears that mail addressed directly to him would be subject to censorship controls. The names used in connection with CABATONS 41, 42 and 43 are fictitious names serving only as indicators to insure that the receivers will know that letters bearing these names are intended for CABATON 38. For BOB info only, the true names of CABATONS 41, 42 and 43 are Identities 1, 2 and 3, respectively.

3. BOB: We would appreciate prompt advice on the specific assignment of each of the above letter drops. We would also like to have some idea of the flow of mail that may be expected through each of these drops, and also whether or not there will be long periods of time when no mail will be coming through. We normally try to keep a minimum of at least one letter every month or two going to each drop.
