1. In a separate dispatch (EGBA-69025, 8 June 1961) we are forwarding a complete summary of the current status of the accommodation addresses which FOB has obtained for BOB use. The purpose of this dispatch is to inform FOB concerning a priority requirement which we have for two additional accommodation addresses in Western Germany. The agents in question are as follows:

Assigned to Cabaton

a. CASPUR-3: Resident of the DDR. If possible, wish to provide the agent with a high-security address by 1 July 1961, in order that test letters may be dispatched by the agent during the period July - August 1961. Address may be shared with trusted agents who are not located behind the Iron Curtain.

b. CAHEN-2: Resident of the DDR. Mailings will come from either the DDR or West Berlin. For your information, the former will be operational mail, the latter mailings to test the letterdrop or to preserve the continuity of the correspondence pattern. If possible, wish to provide the agent with a high-security address by 1 July 1961. Address may be shared with trusted agents who are not located behind the Iron Curtain.
