As stated in reference C, the excellent service given by CABATON-32 is most appreciated and we are sorry not to be able to continue to use this tested and reliable drop. However, because of the known risk of censorship, we do not feel justified in using any accommodation address in the Bonn area for an inside reporting agent. This Base therefore has no further interest in CABATON-32, but no objection to the issuance of this drop to another area after a period of six weeks.</p> <p>2. Our interest, and presumably yours, in CABATON-67 is dependent upon the continuation of contact with CABATON-32. Should CABATON-32 be terminated, we assume CABATON-67 would no longer be available as an unwitting drop. We will not assign CABATON-67 to any operation, pending further information from you on this point.</p> <p>3. One other outstanding question relating to CABATON-32 is your doubt as to whether her business address at her former city of residence was ever issued to CATHYROID-3. Through an oversight, you were never informed that the address was not issued.</p> <p>4. Your early notification to us of CABATON-32's change of address, together with the availability of a suitable replacement for her, is greatly appreciated.</p>
