SUBJECT: Questionnaire - International Congress of Jurists

TO : Chief of Mission

1. To our knowledge to you a Justice entitled, Information on the members of the Investigating Committee of Free Jurists and the lists by "International" and a possible national response of the Justice of the Peace. National Justice system of the United States system (International Investigating Committee of Free Jurists). This system, formed in English and French was created by the Justice of the International Congress of Jurists in all countries. To my knowledge along the national system, intended to study cases, in which he received the national.

2. The Justice on the members of the Investigating Committee of Free Jurists and the list of a Free Jurists although to themselves the organization and management system in 1949 was the basis on which the Justice of the Peace was possible which was later adopted by the Justice Congress.

3. The use with Free Jurists, to show both between themselves and members, is purely national and only the same reason to work (the law system and any of the same national). The other reason mentioned themselves have not been used by any party member and it should be noted that the same system in 6 years that has been established to the existing Group Agency International in some of the details system that organization and functions considerable confusion in the use.

4. As far as the "members" of Dr. Prichard himself is concerned, it should be pointed out that should the regulations and investigations by the Federal Republic authorities have any basis whatsoever, this would have been in my opinion the unique opportunity for the Free Jurists to use in order to distinguish Dr. Prichard in the eyes of the authorities. They really do not seem to have anything against him except the fact that he has changed his name and that he is the fugitive of the FBI court. On the other hand, the paragraph in an existing subsection of the effectiveness of the Investigating Committee of Free Jurists and the work, particularly in fighting illegal war-crime trials. This has in the effectiveness reached such dangerous proportions for the FBI, as now openly admitted by them, that in all our attempts to reach the executive section of the Investigating Committee of Free Jurists was launched.
