RETAIN OR DESTROY

1. REF A APPROVED AS STOPGAP MEASURE. NOW STUDYING ALTERNATE MEANS FUTURE FINANCING. GENERALLY AGREE ESTABLISHING SC ON PERMANENT BASIS PROVIDED IT CONFINE ITSELF TO PUBLICIZING CONGRESS AND FOLLOWING THRU ON RESOLUTIONS. FURTHER STUDY MUST ALSO BE GIVEN PLANTING DYCLAVIER CONTROLLED INDIVIDUAL INTO SC.

2. NOW DISCUSSING WITH INTERESTED COUNTRY DESKS CONSTITUENT ASSEMBLY OF EXILES (CA) WHICH WE HOPE NOT ORGANIZED IN MANNER MAKING DIFFICULT CREATION NATIONAL MEMBERS AS SEPARATE ENTITIES UNDER DIRECT CONTROL WHERE POSSIBLE OF APPROPRIATE COUNTRY DESK OFFICERS IN FIELD ALONG LINES SET FORTH 4974 CRUG. ALL CONCERNED WELCOME ESTABLISHMENT CA, BUT FEEL THAT SELECTION NATIONAL MEMBER REPRESENTATIVES SHOULD BE MADE PRIOR MEETING PARA 8 REF B, AT WHICH DYCLAVIER SELECTED SHOULD ORGANIZE SELVES INTO CA.

3. INTERESTED COUNTRY DESKS NOW PURSUING FIELD TO DETERMINE EXISTENT CAPABILITIES ESTABLISH CONTACT AND EARLY WORK OVER REGIONAL AND NATIONAL NETWORK. IN MEANTIME

SUGGEST YOU COORDINATE RUSSIAN, POLISH, CZECH, AND IF POSSIBLE, HUNGARIAN ACTIVITY. APPARENT THAT SUPERVISION CAP WILL REQUIRE ASSIGNMENT SUITABLE CASE OFFICER TO COORDINATE MULTINATIONAL ACTIVITY THIS PROGRAM.

4. RE PARA 10 REF B: FULLY ^{SECRET} ~~SECRET~~ MOMENTUM OF CONGRESS SHOULD BE PRESERVED. STILL UNCERTAIN AS TO WHAT COVER IS AVAILABLE IN BRITISH SUBSIDARY CAP FROM TOP. REQUEST YOUR VIEWS.

5. WOULD APPRECIATE BEING KEPT FULLY INFORMED TO ENSURE PROPER COORDINATION THIS END. ALSO REQUEST FULL DETAILS ON CONGRESS PRESS AND FILM COVERAGE, TEXTS OF SOLUTIONS, AND DISPATCHES, ETC. FOR FURTHER EVALUATION HERE.
