1. In accordance with [ ] request for the true identity of the TPEMBER Apparat staff personnel represented on the Apparat table of organization, see reference, we are enclosing this information as Attachment A.

2. It should be noted that identity eight will be employed as a case officer, which will enable identity four to assume the position of Transportation Officer ("Referat T.O."). Identity four will then be able to devote his full time to infiltration and casing activity. Similarly identity nine will be employed as a case officer in order to release identity one from those duties. Identity one will then be in charge of DTAKYGD activity. These moves should facilitate the development of casing and DTAKYGD operations.

3. As Identities one and seven were associated with TPEMBER prior to assuming their duties with the Apparat, we have incomplete records on them. We have obtained completed "IX" forms from them and are preparing to request field clearances. The Apparat's registrar was returned to TPEMBER when the Apparat moved to new quarters in order to achieve greater compartmentation from TPEMBER.
