**a. Action Reported by the Field:**

The field requested that an attempt be made to salvage some of the 40 East Zone individuals who were formerly members of CADROWN and who were considered "uncontaminated" by a BOB/CART investigation of that project in late 1953. The field has also requested that CAVERDICT, a former CADROWN staffer be used as a principal agent in this salvage operation. Contact has already been made with three of these East Zone residents and further assessment and testing of them has been scheduled for the month of August. See also CACINNABAR monthly report.

**b. Pending Action:**

The field has been asked to notify Headquarters when all obligations against CADROWN have been reported. When such notification has been received, a formal termination request for CADROWN will be submitted.

Headquarters has approved requests (see para 10 a above) from the field and has authorized the inclusion of these former CADROWN assets into Project CACINNABAR in cases where the subjects are deemed suitable as agent material. Name traces on the three East Zoners have been run and POA's granted for them under CACINNABAR. A clearance amendment for CAVERDICT, authorizing his use as P/A under CACINNABAR, is expected in the near future.
