During the past project year, CAGENERAL-3 was terminated because the Czech Intelligence Service manifested an interest in her and in her relatives still residing in the CSR.

(c) Additions:

During the past year, five new addresses--CAGENERALS 4 through 8--were added to the Project. CAGENERAL-6 (former AECACETA-9) and CAGENERAL-8 (former AEANGEL-2) were transferred from the Munich Base SR element.

(d) Future personnel plans call for the recruitment of 12 or 14 additional accommodation addresses during the coming year. Included in this number are two listed by the field as CAGENERALS 9 and 10 on the list of recruited and active addresses. Because clarification of the identities

and clearance status of these is still the subject of correspondence between Headquarters and the Field, they are being included among the 12 to 14 prospective recruits rather than among the recruited and active addressees. Should clarification be effected in the course of the processing of this approval request, the necessary adjustments will be made in the text.
