Angola: [Holden Roberto, leader of the Angolan provisional government, reportedly sees no alternative to forming a common front with the Communist-backed Popular Movement for the Liberation of Angola (MPLA). He apparently is concerned that unless he can soon obtain enough funds to feed, clothe, and equip his partisans, his movement will either collapse or be taken over by the MPLA by default.]

[Roberto faces mounting international pressure, particularly from Afro-Asian states, to unite in a common front with the MPLA and other Angolan nationalist groups. At the recent conference of African nationalists in Ghana, Angolan delegates were probably under considerable pressure to merge, following the announced formation of a united front by the two leading Mozambique nationalist movements. Afro-Asian states have made offers of assistance to Roberto conditional on his forming a common front with the MPLA.]

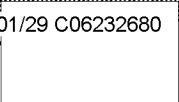

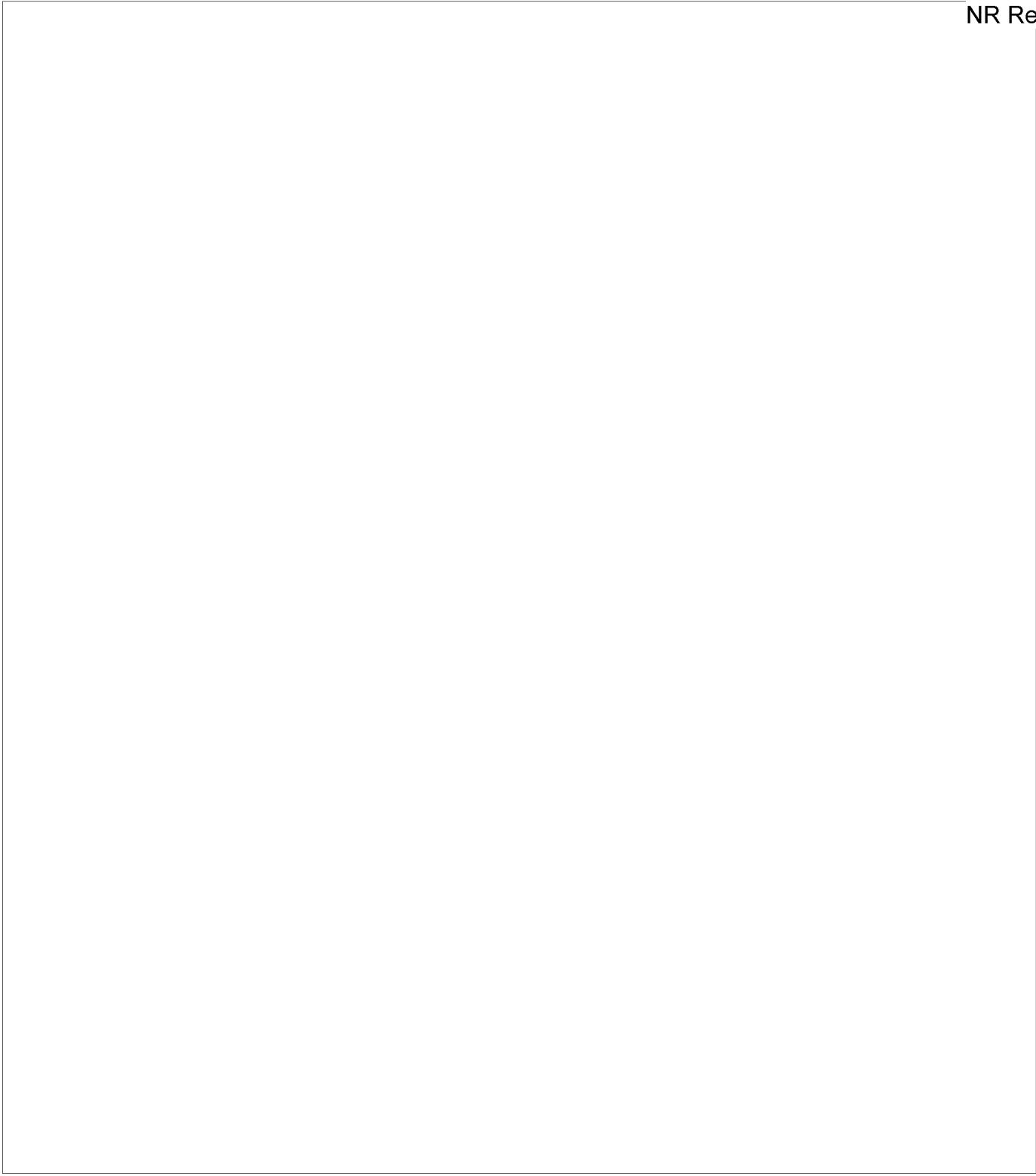
