Dear Dr. Sampson:

As you know, I have arranged for the historians working on the Vietnam War volumes of the Foreign Relations of the United States series to screen the documents they order from presidential libraries after we receive them here. Drs. Baehler, Keefer and Landa visited our offices in December and January and screened ten separate groups of documents that they had selected at the John F. Kennedy Library, to identify the specific documents they would like CIA to review and release for this project.

After review, the originating components here have given me a decision on two more of the ten groups of Kennedy Library documents that these three historians screened. (We reported on the first six groups in our letters to you of 17 February, 2 March, and 3 July 1984, and two more groups are still under review.) Of the 7 documents that were selected for review from this group at hand, I can forward 3 documents for release, since the originating components have denied the other 4 documents.

I shall enclose copies of the Kennedy Library manifests that include these documents from the following groups:

Group E: JFK Manifest Nos. 11-16, 19, and 20

Group G: JFK Manifest Nos. 18, 21, 27, and 29

You will note on these enclosed manifests that we have numbered each document received from the Kennedy Library. Drs. Baehler, Landa and Keefer used these numbers (indicated below in the "HS/JFK Document #" column) in

screening these documents, and for their information the results of our review are summarized below:

We understand that we need not arrange for review of any other documents in this group, unless Drs. Baehler, Keefer or Landa (or some other historian working on this project) selects specific additional documents for review.

As usual, the caveats noted in the enclosed "CIA Records Access Policy" apply concerning CIA review before any material from CIA-originated documents can be downgraded, declassified or published in any unclassified publication.

I am sending a copy of this letter to Ms. Suzanne K. Forbes, Classification Review Archivist at the Kennedy Library, and to Dr. James E. O'Neill, Assistant Archivist for Presidential Libraries at the National Archives and Records Service.
