3) If no action is taken the treaty will expire in five years.

The controversy centers around whether the date of signing or the date of ratification is determing. If it is the date of signing, 1962, then neither Honduras or El Salvador is obliged to follow the procedures outlined in the Villeda-Cordon Agreement; if, on the other hand, it is the date of deposit, 1963, the treaty is still valid.

Negotiations are now underway under the Villeda-Cordon Treaty and neither El Salvador nor Hondura has raised the question of the Treaty's validity.
