The B.G. (Alteration of Boundaries)
Order in Council 1954

- 1. This Order may be cited as the B.G. (Alternation of Boundaries) Order in Council 1954.
- 2. The boundaries of the Colony of British
 Guiana are hereby extended to include the
 area of the continental shelf being the seabed
 and its subsoil which lies beneath the high seas
 contiguous to the territorial waters of British
 Guiana.
- 3. Nothing in the Order shall be deemed to affect the character as high seas of any waters above the said area of the continental shelf.
