MEMORANDUM FOR THE ASSISTANT DIRECTOR FOR COLLECTION AND DISSEMINATION:

SUBJECT: CIG Directive No. 18

1. In connection with the implementation of the subject directive, the Office of Collection and Dissemination will:

a. Insure sufficient review of current and future agency collection directives as may be necessary to determine, on a continuing basis, their appropriateness under the policies and objectives established by the subject directive.

b. In the process of reviewing agency collection directives, initiate appropriate corrective action, when necessary, as prescribed in paragraph 3 of the subject directive, preparing communications, in suitable instances, for the signature of the Director or Deputy Director of Central Intelligence.

c. Assist ICAPS in the preparation for, and attend, the monthly interagency meetings, provided for in the Deputy Director's memorandum of 29 January 1947, subject: "Implementation of NIA Directive No. 7", which will consider collection policy matters which might require ultimate resolution by IAB action.

d. Conduct the interagency meetings made necessary by paragraph 2 of the subject directive, to consider operational collection coordination matters which are possible of solution within established NIA or CIG policies, procedures and objectives.

AMENDMENT TO C.I.G. DIRECTIVE NO. 18

COORDINATION OF COLLECTION ACTIVITIES

Memorandum by the Secretary

1. The Director of Central Intelligence and the Intelligence Advisory Board have agreed to amend paragraph 1 B 3 (b) of C.I.G. Directive No. 18, dated 23 January 1947, which now reads:

"(b) Insure to the best of his ability that the collection missions of the respective department or agency representatives are being promptly and adequately accomplished; that collection duplication is avoided; and that the information obtained is properly channeled."

to read:

"(b) Insure that unproductive collection duplication is avoided; and that the information obtained is properly channeled."

2. It is, therefore, requested that the attached amended page 2 of C.I.G. Directive No. 18 be substituted for the original page 2 of that Directive and all superseded pages be destroyed by burning.
