1. I AM PAINFULLY AWARE OF THE PREDICAMENT WHICH YOU DESCRIBE. I AM ALSO AWARE THAT LAST JANUARY I PROMISED TO TELL THE JACKSON OFFICE SOMETHING BY MARCH. IT IS NOW MAY.

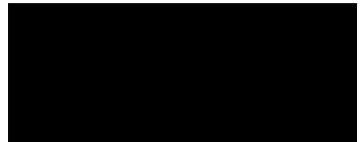
