The Federal Bar Association, in the interest of its members, has undertaken to assemble information which may affect the status of lawyers employed in the Government service. While the legal staffs of the executive agencies may, by and large, not have been recruited through the civil service, there is no doubt that the head of each legal division has taken significant steps to insure that his staff is an effective one composed of qualified attorneys chosen on a merit basis.
