The classification of this document is: "Restricted" Subject: "Japan. Daily Report of Foreign Broadcast Intelligence Service, FCC, for May 18, 1945." It contains information relative to reactions to unconditional surrender statement, Bureaucrats caused IRAA downfall, government use of radio for transmitting official messages, note protesting Sinking of Awa Maru sent to United States, and amalgamation of Tokyo Medical Service. One manila folder, marked "Miscellaneous No. 9 P J J".

This document is headed as follows: Chungking. 8/25-653 P. FCCF-A 297. This is a text of Radio Tokyo broadcast in English to North America (directed to Ventura) relative to mail service in China.

The subject of this document is: "Chungking-Damage in Changteh by Japanese soldiers; Chinese Air Force Plans." It is dated November 25, 1943. This is a copy of an intercept of Foreign news broadcast. Long hand notation "Changteh, a Chinese Stalingrad?"

Radio Report on The Far East, number 38, marked "Restricted", January 31, 1944. Foreign Broadcast Intelligence Service, Federal Communications Commission.

This document is headed as follows: "F.C.C.F - A 237, Chungking in English at 10 A.M. to North America and East Asia." This is a text of Chungking broadcast in English April 19, 1944 to North America and East Asia relative to an explosion in Bombay.

Carbon copy of document captioned, Communist Assail Chiang War Policy. Setting forth what appears to be a Domei News Cast relating to KMT and Chinese Communist fiction, as well as information re military situation at that time, July 17, 1944.

Carbon copies of teletypes. A number of carbon copies of teletypes of what are apparently news releases most of which deal with Far Eastern matters.

This document is headed as follows: "FCCF-A50, Tokyo (Domei), in English at 11:09p.m. Monday to the Pacific." This is excerpts from the texts of a Domei broadcast in English on April 18, 1944 to the Pacific relative to General. Hsin Shin - lien, Ministry of Foreign Affairs.

A franked envelope of OWI, not mailed, containing a large number of carbon copies of teletypes. These teletypes deal with what appear to be news releases on current events. The envelope has the name of [REDACTED] on it and No. W811.

This is an FCC report from radio sources dealing with Chinese and Far Eastern matters. Pages E-11 and 11 and AA1 to AA 9.

This is an FCC report from radio sources on Japanese matters pages EA 9 through EA 20.

This document contains copies of three FCC teletypes giving information from radio sources on Far East.

This exhibit contains the following:

- (A) Four by six card in reference to Intelligence Systems, April 29, 1944, "Manchuria". Discussion of why the Allies have to attempt closer cooperation.
- (B) AP News Report by Clyde Farnsworth dated at Kunming, April 24, 1944, (delayed). This concerns the strategy of the Japanese and the New Style Puppet Troops of the Japanese.

On the top of this page is a longhand notation: "Isn't this going too far? There can't be any Japanese troops left in Manchuria!"

This exhibit consists of the following: (a) FCCF A241. "Restricted", July 18, 1944. Text of Tokyo (Domei) broadcast in English, July 18, 1944, to America, relative to the Japanese offensive against Hengyang. (b) FCCW A261, "Restricted", July 17, 1944. Text of Berlin radio broadcast in German, July 17, 1944, to North and Latin America, relative to the resistance being offered by Chungking troops in Hengyang. Longhand notations on the reverse side of (a): "Bales file" and "Proof that Col. Bales is wrong saying that the Chinese are not holding Hengyang."

Subject of this document is: "North - Central - South China." This document is "Restricted" and is pages F1. After an introductory paragraph relative to National Recovery Day, this memo discusses the whereabouts of Wang Ching - wei, puppet President of Nanking. Longhand notations: "Personalities file, Entered. August 1, 1944. Where is Wang Ching - wei?"

The subject of this document is: "Official Japanese Broadcast, North American Affairs." Pages FA1 and FA 2 set out information relative to "North American Affairs", including Red Cross note to Military Headquarters and Reich's prisoner program, and Bose's brilliance as Army head in his first broadcast in Burma under the section on "Near and Middle Eastern Affairs." Pages J1 through J6

are captioned: "India" and various sentences relative to Bose and to the National Government of Azad Hind are underlined in red.

This document consists of one page which is captioned "FCC Items on China," press despatch. Miscellaneous items include: National Administrative Conference in Chungking; Kuomintang-Communist negotiations; ban on sending students abroad; data relates to censorship. It is indicated that this information is from radio sources.

This document bears the following: FCCF-A 313, August 3, 1944, Chungking. Subject: "Text of Chungking Broadcast in English, August 3, 1944, to North America Announcing the Appointment of Dr. Victor Hoo to be China's Delegate to the Forthcoming Post-War Security Conference."

This is a half of a mimeograph page setting out current activities of the various individuals in China, including Chu Tah, Chang Li - Shing, Information Minister Lin Po - sheng and Madam Chiang Kai-shek. Reverse side of the page contains sketches of individuals in Manila. Pencil notation: "FCC July 17, 1944".

This exhibit contains the following:

This document was prepared by FCC. It is pages BA, BA 23, captioned: "Japan Political" which sets out information regarding the new political party, "Dai Nippon Political Association." Notations in red pencil: "Pers." and "Minami" and "March 30, 1943." It is indicated that this information is from Radio Sources.

This is a Federal Communication report beginning F.C.C. F.A. 79 - Hsinking in English at 1:30 A.M. to Western North America etc.

This document consists of 2 $\frac{1}{4}$  sheets which are mimeographed on both sides. Pages C-1, C-2, C-3 and C-4 are headed "Three China," (Restricted) with the following subheadings: "PPC Meetings, Censorship Relaxation and Chungking Communist Relations. The one fourth sheet concerns criticism of Chungking.

This exhibit was prepared by the Federal Communications Commission. One sheet of mimeographed paper on both sides (Pages C-1 and C-2) headed "Free China", "Restricted" with subheadings:

This document is a radio intercept from Japanese radio. It bears the following notation: "F.C.C.F. #213. Subject: "News on Parade" by Yesua Yamada.

This exhibit consists of a number of newspaper clippings and handwritten notes made in connection with Far Eastern matters and one F.C.C. report of official Chinese broadcasts and a carbon copy of a two page document headed "Farewell to a Great Boss."

This exhibit consists of the following: "Daily report - foreign radio broadcast." This is a report prepared by Foreign Broadcast Intelligence Service, Federal Communications Commission, dated June 5, 1945, and is marked "Restricted for a period of ten days from date." There is also a brown envelope addressed to Mr. E. S. Larson, Department of State, Far East Research and Planning Unit, Room 814, Walker Johnson Building, Washington 25, D. C., from the Federal Communications Commission.

This document is headed "Restricted for a period of ten days from date", for government use only, not for publication. It is dated Monday, June 4, 1945. It was prepared by the Foreign Broadcast Intelligence Service, Federal Communications Commission. Title: "Daily Report - Foreign Radio Broadcast."

This document is dated December 23, 1943, Chungking, containing comments by Lt. Gen. A. Carton De Wiart on the Chinese Army's building of mounting and offensive against the Japanese. He stated that victory could come within 1 year.

This is a "Restricted" document dated December 22, 1944, "for government use only - not for publication." Subject: Supplement to Radio Report of the Far East No. 61. It was prepared by Foreign Broadcast Intelligence Service, Federal Communications Commission. The contents of this document are as follows: "Third Greater East Asia War", "Anniversary." "The Kamikaze Special Attack Corps" and "Enemy Broadcasts to the Chinese."

This document is restricted information obtained from radio sources on North-Central-South China.

Foreign Broadcast Intelligence Service, FCC, reports captioned Japan, for May 3, 4, 7, 8, 1945. May 3, 1945 report relates to the possible Army and Navy beach, General Minami's address to Diet members, and the denouncement of destruction of Christian Churches. May 4, 1945 report relates to the eulogy of Hitler and Mussolini, Japan's determination to continue fight, Mainichi Shimbun's criticism of Suzuki and denouncement of U. S. aims by Kagawa. May 7, 1945 report relates to Togo's denunciation of pact praised, press denounces Germany for Betrayal of Japan, and Doihara appointed to Supreme War Council. May 8, 1945 report relates to Togo's announcement of Germany's surrender, and suggestions for a security plan. (All of this information is from radio sources).

This document was prepared by the Federal Communication Commission. It is from JGTA 141530Z to CWI. It contains news items referring to Japan and the Japanese activities, and the Declaration of Independence of King of Cambodia.

This document was prepared by the Federal Communications Commission. WAI00 from KGTA 211415Z. It contains news releases referring to the activities in the Far East. It includes some data relating to battles and Japanese comments on them.

The subject of this document is: "Intel. Codes." This is an FCC intercept dated October 27, 1943 of Berlin (transocean) news broadcast to North America relative to new Chinese telegraph key. Longhand notes: "Mr. [REDACTED]" and "Intel. Codes Telegraph Key".

This is an intercept of a foreign news broadcast relative to the Governor Pro Tem of New Caledonia. It is dated November 17, 1943, Noumen, New Caledonia, concerning Christian Leigrel. It is indicated that this information was obtained from radio sources.

This exhibit consists of 10 Federal Communications Commission intercepts relative to intelligence in China, particularly in the Canton, Hainan, Shanghai and Java areas, from October 1943 to February 1944, as well as two notes on 3x5 slips of paper, relative to: "Canton Area Intelligence Notes" and Department of State's views relative to Gauss's suggestion that any U.S. mission to Yenan has to be military.

This document was prepared by the Federal Communications Commission. Chungking Tass despatch in Russian at 9:30 A. M. Sunday to East Asia. Article tells of increased demands for a Democratic Government in China.

This document is in the subject: "Manchuria." It is dated January 5, 1945. In the upper left hand corner appears the following: "FCC No. 62, January 5, 1945. This is page D-1, "Restricted".

The following appears in the upper right hand corner of this document: "Far East No. 707, November 22, 1944." This is personal information from a Domei despatch dated November 17, 1944, on the death of Wang Ching Wei.

This document contains radio reports on Free China.

This document has the notation in the upper left hand corner as follows: "FCC, July 21, 1944. In the center of this document is - C 1 - and underneath that is the word "Restricted." The subject of this document is: "Free China."

This document was prepared by the Federal Communications Commission. FCC report on India from radio sources. It is marked "Restricted." It contains considerable comment on Bose's ideas for India's future.

This document is a "Restricted" report prepared by the Federal Communications Commission and is captioned "Domei News Agency". It starts with a translation from the Domei Yearbook for 1941 and gives the history, background, and activities of the Domei. It goes into great detail as to coverage and organization.

This document is a Federal Communications Report on Japan, "Restricted", obtained from radio sources. It describes recent moves of Central Government and cabinet moves as well as information regarding personalities in Japan and comments on societies there.

Extracts from what are apparently FCC radio intercepts dealing with YENAN criticism of a statement of one Wang of KMT propaganda department. Comments on possible revisions of United States foreign policy toward Yen-an and comments on military activities and plans in China.

This document has a notation in ink: "FCC Radio Report No. 62, January 5, 1945." Subject: "India" it is pages M1 and M2. The report contains information concerning the "Provisional Government of Azad Hind" and also the state of Gandhi's health. The word "India" has been printed in large letters with a red pencil. It is indicated that this is from radio sources.

This report has the notation in ink: "FCC Report No. 62, January 5, 1945."

- (A) Subject: "Military Affairs." This discusses the following personal intelligence, etc. Red pencil notation: "Japan"
- (B) OWI Translation Service, Special Issue, Chengtu Branch. This is undated, but bears the caption "Chengtu Cultural Circles Issue Declaration on Current" a red pencil notation states: "Criticism of Chiang's Speeches."

In the Top Center of this document is "AB1, Restricted". It is captioned: "The Indian Independence Leagues of the East Asia." The report deals with the early activity, structure of the league. There is notation at top in green pencil "FCC C49-July 7, 1944". It is indicated this information is from radio sources.

This is special report No. 90. FCC Foreign Broadcast Intelligence Service, August 16, 1943. "Confidential". Subject: "Radio Tokyo Commentators and Features." It is 11 page report setting out information regarding broadcasts of various commentators whose broadcasts are regularly beamed to America from Radio Tokyo. It is indicated that this information is from radio sources.

At the top of this document is "Restricted", - K1 - . It is captioned "India". It is report covering Azad Hind on the March, proof is the fighting, Bose at the front, Function of the Indian National Army, Provisional Government's Plan for Unification, Jubilation of GEA Indians, death of Mrs. Gandhi and publication

notes. Notation at top in green pencil "FCC 40, March 2, 1944".  
It is indicated that this information is from radio sources.

This document is "Restricted" and appears to be torn from a notebook or bulletin (pages AB1 to AB 9) and it refers to the occupation and resistance in Kiang Su. This includes data on organization, military action, recruits, education and enemy strength of the resistance and puppet administration, economic developments, Kaing-Su defense, and military training relative to occupation. It appears that this information is from radio sources.

This document consists of extracts from the Federal Communications intercepts of short wave broadcasts from Tokyo and Korea and other affiliated stations from December, 1941 to December 31, 1944, and from other OSS sources. This report begins as follows: "This document contains information affecting the national defense of the United States within the meaning of Espionage Act . . ." This is a "Confidential" report.
