Proposed Bill on Reserve of "Less than Executive Level"

REFERENCE: Your Memorandum, 14 January 1959, Same Subject

1. I have carefully reviewed the subject bill. There are several features which would give us some concern from the standpoint of establishing a reserve group for this Agency, composed of selected individuals having specialized skills who are cleared and ready to augment our staff at very short notice.

no change 46
a. Section 2 of this latest draft prevents reservists from being or becoming employees or officers of the Federal Government by reason of civilian reserve status. We are appointing these people to our rolls in a fashion which requires only the issuance of travel orders to bring them on duty either for pre-emergency training or for emergency duty.

17 months draft 46
b. Section 3b places a 20% limitation on number on duty in a pay status at one time. This restriction would lead to administrative and training problems, particularly with a small reserve group. Since it is our plan to recruit only people having the basic qualifications, this period of pre-emergency training would be restricted to refresher training only. A two weeks a year limitation would not be unreasonable if it was felt necessary to place some kind of restrictive clause in the legislation.

no change 46
c. Section 3b makes salary payments dependent upon a showing of hardship and inequity. We would find this provision difficult to administer.

d. Section 5 provides for regulations which could well cause security problems to this Agency.

2. I appreciate the opportunity of furnishing these informal comments. This reply deals with administrative points only and in no way constitutes an Agency position on the proposed legislation.
