The papers on the Soviet economy were interesting, but not particularly surprising in content or meaning, and were insufficiently oriented towards interpretation of the latest developments in the relevant areas of investigation. The opportunity of hearing the papers delivered is a less important aspect of attendance, for they may be perused later upon publication of the Proceedings and attendance is too large to permit frequent questionings of the speakers and discussants either during or after the session. Nonetheless, it was a pleasure to 25X1A9a witness the very commendable performance of Analysis Division in his discussion and critique of a paper concerning developments in the economy of Communist China. In a roundtable discussion of the market for economists I was sorry to see that the Agency lost an excellent opportunity to have one of its representatives speak to the discussants concerning the qualifications the Agency desires and its needs in securing additional professionals for economic research. However, the arrangement of the agenda of the roundtable may have been informal so that there was no certainty that an agency representative would be called upon.
