1. Psychological Aspects of Prisoner of War Interrogation

Arrangements have been completed for twenty Agency employees to attend the program, "Psychological Aspects of Prisoner of War Interrogation," to be held at the Pentagon on 8 May. Colonel Robert Work, Office of the Assistant Secretary of Defense for Health and Medicine, granted us twenty, subsequent to a smaller number previously authorized. A letter was sent to Colonel Work stating that all Agency people who will attend understand that the material to be presented is for official use only. 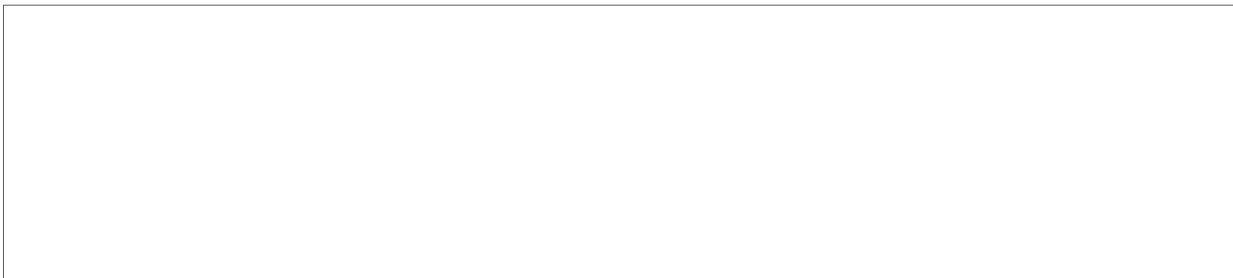
