- 1. Attached for your review and approval are proposed changes in the ergenisation of O/SI. These changes are based primarily upon and stem from the intelligence research and production program scheduled for implementation July 1. Your approval in principle of these changes prior to your departure on June 8 is urgently required if we are to meet the July 1 deadline.
- 2. It should be noted that the attached discussion and proposed organizational changes deal solely with the intelligence research and production responsibilities customarily associated with OSI but they are consistent with the recommendations submitted to you by Professor dealing with the broad over-all organization of the scientific effort within the Agency.
