- NARROWER SIGNIFICANCE FORMER ATTACHES COCOM CONTROLS, UK COOPERATION WITH U.S. IN TRADE CONTROL EFFORT IN FUTURE LARGELY DEPENDENT LEVEL TO WHICH US ABLE TO REDUCE CONTROL OBJECTIVES. WHILE BOTH PRESSING FOR EXPANDED TRADE WITH SINO-SOVIET BLOC, FONOFF SENSITIVE TO NEED WIDE RANGE US-UK COOPERATION MANY FIELDS.

3. A. REF (A) SITUATION (1):

MAINTENANCE CURRENT US POSITION ON CHINA DIFFER-ENTIAL WOULD PROBABLY HAVE NO IMMEDIATE EFFECT PRESENT COCOM LISTS, BUT ON LONG TERM WOULD CERTAINLY LEAD DISINTEGRATION CHINCOM WITH RESULTANT DAMAGE TO COCOM COOPERATION.

B. SITUATION (2):

AS INDICATED RESULTS SECRETARY'S APPROACH TO LLOYD AT MAY NAC MEETING, LIMITED U.S. CONCESSION WOULD PROBABLY HAVE LITTLE EFFECT UK ATTITUDES DESCRIBED ABOVE.

C. SITUATION (3):

UK US MADE SIZABLE ACCOMMODATION TO MAJORITY VIEW, CHINCOM CONTROLS WOULD MERELY BE FACADE, AND US, TO OBTAIN MUCH BENEFIT FROM ACCOMMODATION, WOULD HAVE TO INDICATE RECOGNITION OF THIS TO PC'S. SUBSTANTIAL ACCOMMODATION ON THESE TERMS MIGHT WELL ENHANCE US RPT US STANDING WITH PC'S BUT DIFFERENTIAL REMNANT, EVEN THOUGH NOT MEANINGFUL, WOULD REMAIN LATENT SOURCE POSSIBLE FUTURE FRICTION.

D. SITUATION (4):

EMB DISPOSED AGREE USDEL VIEW (PARA 4(D) POLTO
484) THAT US AGREEMENT IMMEDIATE DIFFERENTIAL ELIMINATION WOULD STRENGTHEN U.S. NEGOTIATING POSITION.
PROBABLE UK (OR OTHER PC'S) WOULD NOT MAKE SPECIFIC
QUID PRO QUO AGREEMENTS IN ADVANCE US ACTION, BUT POSSIBLE
US MIGHT STILL BE ABLE "BUY" SHORT TERM INSURANCE (6
MO?) AGAINST FURTHER COCOM RELAXATION. IN THIS CONNECTION, FONOFF REP RECENTLY INDICATED INFORMALLY RESPONSE
EMB QUERY THERMONUCLEAR LIST REVISION STILL UK GOAL,
