Gentlemen:

1. Reference is made to Letter Contract No. TE-2191 effective 1 May 1957 between the United States of America and Edgerton, Gerneshausen and Grier, Inc., Las Vegas, Nevada.

2. The parties hereto agree to amend the contract as hereinafter set forth.

- (a) Delete the figure "\$121,000.00" appearing in Paragraph 5, Authority to Obligate Funds and substitute the figure "\$192,500.00".
- (b) Add to paragraph 6(b) after the wording "practice any such invention" the following:

"Despite the statement above with reference to title to patents produced hereunder, the Contracting Officer agrees to negotiate with the Contractor at the time of finalizing this Letter Contract to arrive at a patent policy with respect to the instant contract which will be consistent with the Contractor's responsibilities and liabilities in the field of patents as defined in the Contractor's Contract No. AT(29-1)-1183 with the Atomic Energy Commission. Such negotiated patent clause will either (a) be consistent with Contract No. AT(29-1)-1183 or (b) will designate the Atomic Energy Commission as patent representative for the instant contract. Copies of Modification No. 26 Supplemental Agreement and Modification No. 26 Appendix C to Contract No. AT(29-1)-1183 are attached hereto."

- (c) In paragraph 3(a) Estimated Cost and Fixed Fee of Exhibit A delete the figure "\$110,000.00" and substitute the figure "\$175,000.00".
- (d) In paragraph 3(b) Estimated Cost and Fixed Fee of Exhibit A delete the "\$11,000.00" and substitute the figure "\$17,500.00".
- (e) The Contracting Officer hereby approves the method of charging time of the Contractor owned Beechcraft Bonanza and further approves as a charge to this contract the charter cost of a specific airplane for certain specific trips when the Contractor owned plane is not available.

3. All other terms and provisions of Letter Contract No. TE-2191 remain as originally stipulated.

4. Please indicate your acceptance hereof in the space provided below. One copy is to be retained for your records and the original and remaining copy is to be returned to the undersigned.
