1. Reference is made to Contract No. SC-58 effective for the period 1 July 1957 through 30 June 1961.

2. SECTION C - PERIOD OF PERFORMANCE of the Contract Schedule, as amended by Amendment No. 12, is deleted and the following is substituted therefor effective 1 July 1961:

"SECTION C - PERIOD OF PERFORMANCE

The Contractor shall perform the services hereunder as required by the Government for the period 1 July 1957 through 30 June 1962."

3. The rates set forth in APPENDIX IV for the period ending 30 June 1961 will be used on a provisional basis beginning 1 July 1961 and thereafter until new rates for the period are negotiated.

4. The first portion of paragraph 3, as amended, of SECTION B - CONSIDERATION AND PAYMENT, is deleted in its entirety and the following is substituted therefor effective 1 July 1961:

"3. There has been allotted for this contract the following amounts:
