
Dear Art:

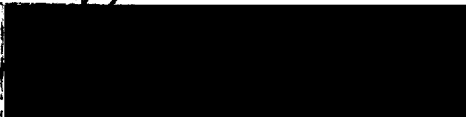
