CONTRACT

The services and equipment being procured by this Contract No. AS-1930 are in furtherance of the IDEALIST Program(s), the nature of which cannot be publicly disclosed for security reasons. The Contracting Officer therefore determines that this procurement must be accomplished by negotiations pursuant to the authority of Section 3(a) of PL 81-110 and Class Determination and Finding, OXC 2122, signed by the DDCI on 15 October 1961.

Certification of funds for this contract will be handled under the procedure approved by the Director of Central Intelligence on 15 December 1956 which, in effect, results in all covert expenses involving issuance of Treasury Checks being accumulated in a separate account within the Finance Division. The amounts in this account will be periodically scheduled for certification of the vouchers by the Director. This procedure eliminates the necessity for a separate certification of authority under Section 8(b) of Public Law 110, 81st Congress (formerly 10(b) - see 85-507 dated 7/7/58) for each contract.

The following comments describe the procurement hereby effected, the terms and provisions generally of this contract/amendment, and a resume of major issues negotiated:

Fixed price contract in the amount of \$35,850 for six (6) each [redacted] who was the original developer of this equipment.

The [redacted] system which is an integral part of the [redacted] program. However, an [redacted] is now being developed under a separate contract. It is a [redacted] system and has more improvements.

The prices were reviewed by both Commo Engineers and the negotiator and are considered reasonable.
