2. Reference our TWX 374 concerning the addition to the vacuum furnace to provide a complete mission's thermal and pressure profile. In addition to the two items noted above, there are two other areas for which we have not yet estimated the costs to any great degree of reliability. These items are therefore not included in the additional funding requested in the letter referenced above.

Item 1, Prototype Flight Testing - this item only includes the cost of the aircraft and flight test facilities necessary to flight test the prototype locally. We have always planned to flight test it in a low altitude, slow-speed aircraft, however, our original plan was that the test bed would be customer-furnished (reference Paragraph 6, Document No. 111). 
