THE SPECIAL ISSUE OF THE AMERICAN WEEKLY NATION DEVOTED TO THE CIA ESPIONAGE AGENCY AND THE BOOK BY BRITISH M.P. BOB EDWARDS, "THE MATTER OF ESPIONAGE" -- FROM WHICH SOME INFORMATION HAS BEEN TAKEN FOR THIS REPORT -- ARE THE LATEST LINKS IN THE LONG CHAIN OF TREATMENTS OF THE DULLES EROTHERS. PRACTICALLY ALL BIOGRAPHIES HIGHLIGHT ONE NOTE-WORTHY CIRCUMSTANCE: THE ALMOST PATHOLOGICAL SYMPATHY OF BOTH BROTHERS FOR GERMANY WHICH, FROM THEIR YOUTH ONWARD, THEY CONSIDERED THE GUARANTEE OF " ORDER IN EUROPE."

THE UNITED STATES HAS WAGED TWO BIG WARS AGAINST GERMANY; BUT ALLEN DULLES, THE ONLY HIGH-RANKING OFFICIAL WHO SERVED UNDER ALL AMERICAN PRÉSIDENTS FROM WILSON TO KENNEDY, THROUGHOUT HIS CAREER WAS A LOYAL ALLY OF ALL REACTIONARY ELEMENTS IN GERMANY, INCLUDING MONARCHIST OFFICERS AS WELL AS MEMBERS OF THE S.S. AND ADENAUER. IT ES HARD TO TELL PRECISELY WHO SUPPORTED WHOM. IN GENERAL, INTERESTS HAVE ALWAYS BEEN IN COMMON. AS EARLY AS IN THE 20'S, THE DULLES FIRM OF SULLIVAN AND CROMWELL MANAGED THE TRANSFER OF FUNDS FROM THE UNITED STATES TO THE GERMAN MONOPOLIES WHICH ASSISTED HITLER TO POWER. AFTER THE ESTABLISHMENT OF THE NAZI REGIME THIS COOPERATION WAS INTENSIFTED, AND THE BANKING ENTERPRISE OF SCHROEDER BECAME THE MAIN MEDIATOR IN NAZI FINANCIAL RELATIONS WITH FOREIGN COUNTRIES. IT IS NOT TO BE WONDERED AT THAT SULLIVAN AND CROMWELL ALSO NUMBERED AMONG ITS CLIENTS THE FASCIST SPANISH STATE BANK AND FINANCIER COUNT RENE DE CHAMERUN, SON-IN-LAW OF THE FRENCH TRAITOR PIERRE LAVAL. THE NEW YORK LAW FIRM BECAME AN IMPORTANT NERVE CENTER OF THE ENTIRE FASCIST CONSPIRACY.

A LAWYER REPRESENTING A MURDERED NATURALLY IS NOT NECESSARILY A MURDERER HIMSELF; THE DULLES BROTHERS, HOWEVER, EXPOSED THEMSELVES FAR MORE THAN BEFITS A LAWYER. IT MUST NOT BE FORGOTTEN THAT THEY HELD NUMEROUS DIRECTORS' POSITIONS IN CORPORATIONS, LIVING ON THE MURDER OF MILLIONS OF PEOPLE. AND IT MUST NOT BE FORGOTTEN EITHER THAT THEY WERE DIRECT PARTNERS OF PEOPLE WHO MURDERED AMERICANS.

THE GERMAN PARTNER OF THE FIRM OF SULLIVAN AND CROMWELL WAS THE LAW FIRM OF ALBERT AND WESTRICK. LET US TAKE DR. ALBERT FIRST: BEFORE THE ENTRY OF THE UNITED STATES INTO WORLD WAR I HE WAS THE HEAD OF GERMAN ESPIONAGE IN THE UNITED STATES. HIS AGENTS COMMITTED SABOTAGE, ANNIHILATED AMERICAN SHIPS, INFECTED CATTLE WITH VARIOUS ILLNESSES --AT A TIME WHEN THERE WAS NO STATE OF WAR BETWEEN THE UNITED STATES AND GERMANY!

THE SECOND PARTNER, DR. GERHARD WESTRICK, CAME TO THE UNITED STATES IN THE SPRING OF 1940. OFFICIALLY HE WAS A TRADE ATTACHE; IN REALITY HOWEVER HE WAS A SPY OF THE NAZI REICH. HIS MAIN CONTACTS WERE HIS "BUSINESS PARTNERS" -- THE DULLES EROTHERS. WHEN WESTRICK WAS EXPELLED FROM THE UNITED STATES AS A NAZI AGENT, JOHN FOSTER DULLES DECLARED: "I DO NOT BELIEVE THAT HE COULD HAVE COMMITTED ANY WRONG. I HAVE KNOWN HIM FOR A LONG TIME AND I HIGHLY APPRECIATE HIS HONESTY."

AFTER THE WAR WESTRICK QUITE OPENLY ADMITTED HAVING INDULGED IN ESPIONAGE AND NAZI PROPAGANDA. HIS BROTHER HOWEVER, DR. LUDGER WESTRICK, WHO NOW IS UNDERSECRETARY IN THE GDR ECONOMIC MINISTRY, IS TRAVELING TO THE UNITED STATES QUITE OFFICIALLY FOR CONSULTA-TIONS WITH IMPORTANT FIGURES, INCLUDING THE HEAD OF AMERICAN ESPIONAGE, ALLEN DULLES.

IN THE FALL OF 1940, THE "AMERICAN FIRST" COMMITTEE WAS FOUNDED IN THE UNITED STATES. IT HAD NO OTHER PURPOSE THAN NAZI PROPAGANDA, THE BLACKENING OF THE ROOSEVELT ADMINISTRATION, AND THE UNDERMINING OF CIVIC MORALE IN THE UNITED STATES. ONE OF ITS LEADERS WAS HENRY FORD; AND ITS STATUTES WERE DRAFTED BY THE LAW FIRM OF SULLIVAN AND CROMWELL.

IN ANY OTHER COUNTRY A PARTNER AND ACTIVE ASSISTANT OF SPIES AND SABOTEURS OF HOSTILE POWERS AT THE VERY LEAST WOULD HAVE BEEN BROUGHT TO TRIAL. THE DULLES BROTHERS DID NOT EVEN RECOIL FROM HAVING NAZI PROPERTY REGISTERED IN THEIR NAME IN ORDER TO SAVE IT FROM SEQUESTRATION. THUS THEY ACTUALLY BECAME BOTH IMPOSTERS AND TRAITORS. IN THE UNITED STATES HOWEVER PROPERTY AND PULL HAVE A GREATER VALUE THAN CIVIC HONOR.

FROM THIS DIPLOMATIC ACTIVITY, ALLEN DULLES WAS ACQUAINTED WITH THE FORMER DEPUTY ATTORNEY GENERAL, WILLIAM J. DONOVAN, KNOWN AS "WILD BILL." AFTER THE U.S. ENTRY INTO THE WAR, "WILD BILL" BECAME A GENERAL--AND HEAD OF THE NEWLY ESTABLISHED OSS INTELLIGENCE SERVICE, OFFICE OF STRATEGIC SERVICES. WITH HIS BLESSING DULLES WAS APPOINTED HEAD OF THE OSS EUROPEAN SERVICE IN BERNE, SWITZERLAND.

HE RETURNED TO THE PLACE WHERE HE HAD BEGUNDAS A YOUNG EMBASSY ATTACHE. THIS TIME HOWEVER IT WAS NOT THE PRESERVATION OF THE AUSTRIAN EMPIRE WHICH WAS AT STAKE: DULLES WAS TO MAKE USE OF HIS CONTACTS WITHIN NAZI GERMANY. FOR A SPY THAT WAS A WONDERFUL QUALIFICATION; BUT DULLES UTILIZED IT IN HIS OWN WAY. HE HAD COMMON IDEOLOGICAL BONDS—AND FINANCIAL BONDS—WITH THE S.S. MEMBERS WHOM AMERICA WAS FIGHTING OFFICIALLY.

ALLEN DULLES! MAIN CONTACT WITH THE NAZIS WAS BARON KURT VON SCHROEDER WHOSE FACE WAS SCARRED FROM PRUSSIAN DUELS AND WHO HAD THE TITLE OF S.S. GRUPPENFUEHERER.

TO MAKE CONTACTS WAS NO PROBLEM IN SWITZERLAND. IN BASLE WAS THE HEADQUARTERS OF AN ADMIRABLE INSTITUTION CALLED THE BANK FOR INTERNATIONAL PAYMENTS. THROUGHOUT EUROPE THE WAS WAS RAGING; IN BASLE HOWEVER, UNDER THE CHAIRMANSHIP OF THE AMERICAN BANKER MCKITTRICK REPRESENTATIVES OF THE BANK OF ENGLAND, AND REPRESENTATIVES OF GERMAN BANKS, INCLUDING ALSO BARON SCHROEDER, WORNED SMOOTHLY SIDE BY SIDE. THEY WERE NOT DISTURBED BY NATIONAL CONSCIENCE; THEY DIVIDED THE WAR PROFITS LIKE GENTLEMEN AND CONDLUDED AGREEMENTS FOR AFTER THE WAR.

IN JANUARY 1943, ROOSEVELT AND CHURCHILL MET IN CASABLANCE AND FROCLAIMED THE DEMAND FOR THE UNCONDITIONAL SURRENDER OF NAZI GERMANY. IN BERNE HOWEVER THERE WAS MR. DULLES, AN OFFICIAL OF THE ROOSEVELT ADMINISTRATION, STRIVING FOR SOMETHING QUITE DIFFERENT: TO MAINTAIN NAZISM WITHOUT HITLER, THEN TO CONCLUDE A SEPARATE PEACE WITH A NEW GERMAN GOVERNMENT AND WITH ITS AID TO ATTACK FROM THE REAR THE ALLY BEARING THE MAIN BURDER OF THE WAR--THE SOVIET UNION. IN HIS MEMORIS DULLES HIMSELF MORE OR LESS HAD ADMITTED THIS. HIS SECRET HOPE IN THIS DIRECTION WAS HEINRICH HIMMLER, HEAD OF THE S.S.

IN THE CONSULTATIONS IN DULLES' OFFICES, NAZI AGENTS, DELEGATES OF HIMMLER, AND THE HEAD OF THE NAZI SECRET SERVICE, SCHELLENBERG, TOOK TURNS. IN REPORTS CAPTURED AFTER THE WAR SOME OF THEM EXPRESSED THEIR WONDER OVER THE "FAVORABLE" ATTITUDE OF "MR. BULL"—WHICH WAS DULLES' COVER NAME—TO THEIR PROPOSALS. HERE IS AN EXCERPT FROM THE REPORT OF S.S. PRINCE MAXIMILIAN HOHENLOHE:

"MR. BULL SAID...THAT HE FINDS IT TIRESOME TO LISTEN CONSTANTLY TO OBSOLETE POLITICIANS EMIGRANTS, AND BIASED JEWS. IN HIS OPINION...THE GERMAN STATE MUST CONTINUE TO EXIST AS A FACTOR OF ORDER AND PROGRESS; ITS DIVISION AND THE SEPARATION OF AUSTRIA IS OUT OF THE QUESTION...MR. BULL SEEMED TO ATTRIBUTE LITTLE IMPORTANCE TO THE CZECH ISSUE. AT THE SAM TIME HE CONSIDERED IT NECESSARY TO SUPPORT A CORDON SANITAIRE AGAINST BOLSHEVISM AND PANSLAVISM..." (MLADA FRONTA ELLIPSIS)

THESE ARE THE VIEWS OF A SECRET AGENT OF AN ADMINISTRATION WHICH HAD A TREATY OF ALLIANCE WITH THE SOVIET UNION AND WHICH COMMITTED ITSELF TO THE REESTABLISHMENT OF CZECHOSLOVAKIA'S INDEPENDENCE. DULLES' PLANS HOWEVER DID NOT SUCCEED; EVEN THE MOST SUBTLE BERNE INTRIGUES FAILED IN THE FACE OF THE NATIONS' DETERMINATION TO ANNIHILATE FASCISM. NAZI GERMANY WAS CRUSHED, MANY OF DULLES' "BUSINESS FRIENDS" FOUND THEMSELVES ON THE WAR CRIMINALS LIST, AND ALLEN DULLES HIMSELF FELT THE NEED TO CONSTRUCT SOME SORT OF AN ALIBI FOR HIMSELF. THAT IS WHY IN COLLIER'S MAGAZINE IN \$\mathbb{X}\$ 1946 HE ADVOCATED THE ANNIHILATION OF PART OF BERLIN AS "A WARNING TO NAZISM AND PRUSSIANISM." ACCORDING TO HIM, BERLIN WAS TO CEASE BEING GERMANYIS CAPITAL; IT WAS TO BE DOMMED TO INSIGNIFICANCE.

THESE WERE NO MORE THAN SO MANY WORDS TO SATISFY THE NAIVE PUBLIC ALARMED BY THE NUMEROUS INDICATIONS OF THE DULLES EROTHERS' TREACHEROUS ACTIVITY. THE ALIBI WAS TO PREPARE THE GROUND FOR FURTHER, SAFER ACTIVITY. (TO BE CONTINUED--MLADA FRONTA)
