(TEXT) BROTHERS DULLES AND CO. MAKE ONE OF THE MOST INTERESTING PAGES IN THE ANNALS OF AMERICAN DIPLOMACY. IT IS TRUE THAT JOHN FOSTER DULLES IS DEAD, BUT HIS BROTHER ALLEN WELSH DULLES IS SUCCESSFULLY CONTINUING THE WORK BEGUN BY THE GREATEST CHAMPION OF COLD WAR.

ALLEN WELSH DULLES BEGAN HIS ESPIONAGE CAREER IN 1942 WHEN GEN. WILLIAM J. DONOVAN APPOINTED HIM EXTRAORDINARY PLENIPOTENTIARY OF AMERICAN INTELLIGENCE IN EUROPE, OR THE OFFICE OF STRATEGIC SERVICES—OSS. THE SEAT OF THE OSS WAS IN SWITZERLAND. IN A BOOK WHICH WAS PUBLISHED IN 1947 UNDER THE TITLE "UNDERGROUND GERMANY," ALLEN DULLES HIMSELF WRTIES: "WE SUCCEEDED IN ESTABLIBHING CONTACT WITH A SECRET GERMAN ORGANIZATION." THIS "SECRET ORGANIZATION" INCLUDED THE MOST OFFICIAL REPRESENTATIVE OF THE STAFF OF THE HINMTRITE ARMY, INCLUDING GEN. SPEIDEL, PRESENT COMMANDER OF NATO LAND FORCES, AND HIGHER STAFF OFFICERS, THE PURPOSE OF THESE CONOACTS WAS TO CONCLUDE A SEPARATE PEACE TREATY WITH HIOLERITE GERMANY TO ENABLE GERMANY TO USE ALL ITS FORCES IN AN ASSAULT ON THE SOVIET UNION.

WE MUST CONCEDE THAT "MR. BULL"--THE PSEUDOMYN UNDER WHICH DULLES BEGAN HIS NEGOTIATIONS WITH HINBTRITE OFFICERS--WAS AIDED CIRCUMSTANCES. HE HAD OLD AND TESTED FRIENDS WITH WHOM HE WAS BOUND BY COMMON INTERESTS: (IN GERMANY--ED.) IN 1.20 THE LEGAL FIRM OF THE BROTHERS DULLES REPRESENTED THE GERMAN GOVERNMENT IN THE UNITED STATES. IN THE FOLLOWING YEARS THE FIRM KNOWN AS SULLIVAN AND CROMWELL, WAS ENTRUSTED WITH THE LEGAL REPRESENTATION IN THE UNITED STATES OF A NUMBER OF BIG GERMAN CONCERNS INCLUDING KRUPP, I. G. FARBEN, FOCKZ-WULF AND OTHERS.

THE CONNECTIONS OF THE FIRM WITH HITLZHITE GERMANY WERE SO STRONG IN THE PERIOD BETWEEN THE WARS THAT ALLEN DULLES JOINED THE BOARD OF THE AMERICAN-GDGVAN SCHRODER BANI IN NEW YORK--- the OFFICIAL FISCAL AGENT IN THE UNITED STATES OF HITLER'S GOVERNMENT AND UNDER THE INFLUENCE OF ROCKEFELLER. MOREOVER DULLES WAS CONSIDERED TO BE AN OFFICIAL REPRESENTATIVE OF THE STANDARD OIL GROUP IN RELATIONS WITH GERMAN MONOPOLIES AND THEIR POLITICAL FRIENDS.

IT IS REMARKABLE THAT THE MEMBERSHIP OF THE SCHRODER BANK INCLUDES-ASIDE FROM A PARTNER OF THE DULLES FIRM, DURREL—ALSO J. LAYLIN, MEMBER OF THE LEGAL FIRM OF COVINGTON AND BURLING. A PARTNER OF THIS FIRM IS DULLES PREDECESSOR AS A SECRETARY OF STATE, DEAN ACHESON, WHO BEGAN THE COLD WAR AND IS A PROMINENT LEADER OF THE DEMOCRATIC PARTY. BUT THE MOST INTERESTING IS THE FACT THAT ABOVE ALL, DULLES CONNECTIONS REACH OUT TO ARMAMENTS MONOPOLIES THE CAPIN IR IDICZBD OVER. THESE ARZ MAINLY CONCERNS WHICH PRODUCE WEAPONS AND MILITARY EQUIPMENT IN THE UNITED STATES AND ABROAD.

EVEN BEFORE FOSTER DULLES TOOK HIS APPOINTMENT AS SECRETARY OF STATE, BOTH BROTHERS HAD BEEN MEMBERS OF THE INTERNATIONAL NICKZL BOARD CONTROLLED BY THE ROCKEFELLERS, MORGANS, AND THE BRITISH ICI CHEMICAL CONCERN. AT THE SAME TIME FOSTER DULLES WAS A DIRECTOR OF THE AMERICAN BRANCH OF THE BABCOCK AND WILCOX CONCERN IN BRITAIN WHICH PRODUCES ATOMIC EQUIPMENT.

ONE OF THE PARTNERS OF THE DULLES FIRM, ANDREWS, WAS A REPRESENTATIVE OF THE ANGLO-DUTCH OIL MONOPOLY--ROYAL DUTCH SHELL--IN THE UNITED STATES. THE OTHER PARTNER, DEAN, WAS A LEGAL ADVISOR TO A GERMAN-AMERICAN CONCERN, THE AMERICAN METAL CORPORATION, WHICH TRADES IN URANIUM.

THIS IS NOT THE FULL LIST OF THE DULLES BROTHERS* CONNECTIONS WITH INTERNATIONAL KINGS OF FINANCE AND INDUSTRY, BUT THE FACTS CITED HERE CLERALY DEMONSTRATE WHAT "SIDELINES" OCCUPIED THE DULLES BROTHERS--ONE OW WHOM WAS A SECRETARY OF STATE AND THE OTHER THE PRESENT CHIEF OF U.S. INTELLIGENCE IN KENNEDY*S GOVERNMENT.
