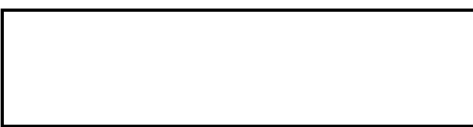



Gentlemen:

1. This document constitutes Amendment No. 1 to Contract No. O-TR-1921 between  and the United States of America.



2. Pursuant to the clause of this contract entitled "CHANGES" and mutual agreement between the parties hereto, it is in the interest of the Government to amend the contract as follows:

a. Pending establishment of fixed rates for the period commencing 1 July 1966 the contractor shall be paid at the provisional rates stated in APPENDIX I for services performed on and after 1 July 1966.

b. Paragraph 3. in SECTION B - CONSIDERATION AND PAYMENT, of the contract schedule is deleted and Paragraphs 3.a. and 3.b., below, are substituted therefor:

"3.a. For the purpose of this contract there has been allotted the following amounts:
