1. This is to confirm our informal advice to you that it would not be proper for [redacted] to serve as a consultant to [redacted] [redacted] in the field of aerodynamics. 25X1A

2. In reaching that conclusion, we had noted your advice that ORD had several contracts with [redacted]. We had shared your concern even though those contracts had not involved [redacted] division or the field of aerodynamics. 25X1A 25X1A

3. The limitations on employee outside activities are not restricted to actual conflict of interest situations but include those having the appearance of a conflict. In prescribing standards of conduct, Executive Order 11222 requires that Government employees avoid any action that might create the appearance of using public office for private gain or giving preferential treatment to any organization (section 201(c)). Suffice to say, under the circumstances indicated [redacted] association with [redacted] would give rise to such an appearance, despite the best of intentions. 25X1A

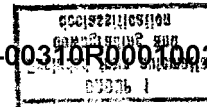

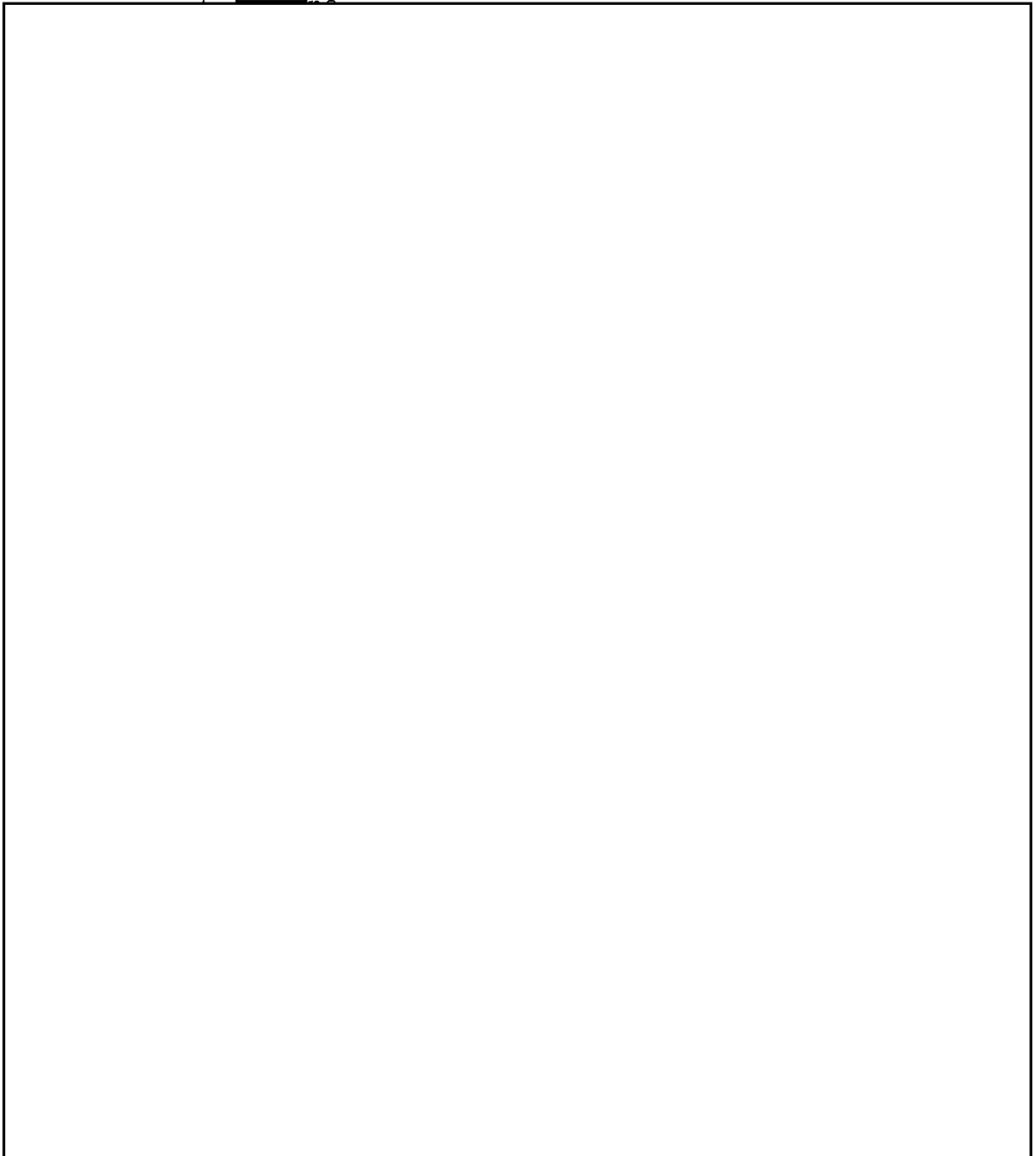

1. [redacted] has requested approval to act as a consultant to [redacted], in the field of aerodynamics. In supporting the request, his division states that they are not currently contracting with [redacted] and that the Office of Research and Development as a whole is not contracting with them in aerodynamics, therefore, there is no conflict of interest.

2. The interrelationships within ORD in implementing systems concepts make it virtually impossible to isolate an individual from activities within his own division and those other divisions concerned in a system development. ORD currently has three active contracts with [redacted] in fields other than aerodynamics. While [redacted] is not involved in these contracts, this office questions the propriety of his association, as a consultant, with a firm currently doing business with the Agency.
