8. [ ] Talked with Mr. Ed Braswell, Chief Counsel, Senate Armed Services Committee, who is recovering from surgery performed earlier in the year. I mentioned our conversation with Jim Woolsey yesterday and said that Carl Duckett would be briefing Woolsey on Soviet strategic defensive systems on Friday morning and that in response to his (Braswell's) request we were giving both Woolsey and Ticer clearances for access to compartmented information.

[ ] Mr. Ralph Preston, House Appropriations Committee staff, and Mr. William Woodruff, Senate Appropriations Committee staff, visited the Headquarters building for briefing on the Agency budget for FY 1972.
