1. PRESIDENT'S BUDGET SUBMITTED TO THE CONGRESS INCLUDES CONTRACT AIR SUPPORT COSTS FOR FY 73 IN THE DEPT. OF AIR FORCE (O&M APPROPRIATION) BUDGET REQUEST. DEPT. OF AIR FORCE HAS AGREED TO ACT AS EXECUTIVE AGENT FOR THE DOD IN THE PLACEMENT AND ADMINISTRATION FOR ALL CONTRACTS FOR AIRLIFT/MAINTENANCE SERVICES SUPPORT FUNDED UNDER LAOS MASF. DETAILS OF CONTRACT SERVICES AND DEGREE OF CONSOLIDATION WILL BE DEFINED IN CONSULTATION WITH AHEMB/USAID VIENTIANE.
2. DEPT. OF AIR FORCE WILL CONSOLIDATE ALL CONTRACTS DETERMINED TO BE UNDER ITS COGNIZANCE ON A TIME-PHASED BASIS DURING FY 73, TO INSURE COMPLETION NO LATER THAN 1 JULY 1973. AIR FORCE HAS DESIGNATED CINCPACAF AS PROCURING COMMAND AND AFLC AS CONTRACT ADMINISTRATION COMMAND.

YOUR PROPOSAL CONTAINED IN REFERENCE MESSAGE IS SATISFACTORY AS A BASIS FOR INITIATING THIS ACTION, INCLUDING DISCUSSIONS WITH AIR FORCE AND AMEMB/USAID VIENTIANE. AT THIS POINT, YOUR PROPOSAL SHOULD BE AMENDED AS REQUIRED TO BE CONSISTENT WITH DIRECTION CONTAINED HEREIN AND ALL ADDRESSEES SHOULD BE ADVISED ACCORDINGLY.
