The CIA Needs Own 'Revolt'

INDEPENDENCE, Mo. - I think it has become necessary to take another look at the purpose and operations of our Central Intelligence Agency - CIA. At least, I would like to submit here the original reason why I thought it necessary to organize this agency during my administration, what I expected it to do and how it was to operate as an arm of the Presi-

that by and large a President's performance in office is as effective as the information he has and the information he gets.

That is to say, that assuming the President himself poscesses a knowledge of our history, a sensitive understanding of our institutions and an insight into the needs and aspirations of the people, he needs to have available to him the most accurate and up-to-theminute information on what is going on everywhere in the world and particularly of the trends and developments in all the danger spots in the contest between East and West. This is an immense task and requires a special kind of intelligence facility.

Of course, overy Presdient has available to him all the information gathered by the many intelligence agencies already in existence.

The Departments of State, Deiense, Commerce, Interior and others are constantly engaged in extensive information-gather-

I think it is fairly obvious ing and have done excellent.

But their collective information reached the president all too frequently in conflicting conclusions. At times the infalligence reports tended to be slauled to conform to established positions of a given department.

This becomes confusing and what's worse, such intelligence is of little use to a president in reaching the right decisions.

I have seen instances where the Army, Navy and the State Department were duplicating their intelligence coverage which resulted in inaccurate conclusions. I have always felt the Posrl Harbor disaster was partly the result of that kind of intelligence confusion.

TOO LATE

It seemed to me that much of the intelligence gathered failand to reach the top levels in the government and that when it did - it was not in proper

In critical times certain important hits of information came too late, thus preventing the adoption of a course of action inecessary to protect our se-

In this new kind of world in which the United States occuples a position of leadership among the free nations, faulty information, careless intelliganco or unintelligent reports on intelligence, or unintelligible conclusions, can prove very dimaging to our policy-making decisions and to the conduct of fereign relations, which is the personal responsibility of the President.

Therefore, I decided to set no a special organization thorged with the collection of zil intelligence reports from every available source and to have those reports reach ma as President without departmental "creatment" or interpretations.

I wanted and needed the information in its "natural raw" gtate and in as comprehensive a volume as it was practical for me to make full use of it

But the most important thing about this move was to guard against the chance of intelligence being used to influence or to lead the president into unwise decisions - and I thought it was necessary that the president do his own thinking and evaluating.

DISTURBED

Since the responsibility for decision-making is his, he has to be sure no information is kent from him for whatever reason at the discretion of any one department or agency or that unpleasant facts are kept from him.

There are slways those who would want to shield a president from bad news or misjudgments to spare him from being "upset."

For some time I have been disturbed by the way the CIA has been diverted from its original assignment. It has become an operational and at times a policy-making arm of the government. This has led to trouble and may have com-

I never had any Caughti when I set up the CIA that It would be injected into peacetime cloak - a n d - dagger operations. Some of the complications and embarrassment I think we bayed experienced are in part attributable to the fact that this quiet intelligence arm of the president has been so removed from its intended role that it is being interpreted as a symbol of sinister and mysterious foreign intrigue - and a subject for Cold War enemy propaganda.

With all the nonsense put out by Communist **- p**ropa រូបរាច់ន about "Yankee Imperialism," "exploitive capitalism," "wrr-mongering," "monopolists," in their name-calling assault on the West, the last thing we needed was for the CIA to be seized upon as someting akin to a subverting influence in the affairs of other people.

OUESTIONS

I well knew the first temporary director of the CIA, Adm. Souers, and the later permanent directors of the ClA, Gen. Hoyt Vandenberg and All in Dalles. These were men of the highest character, patriolism and integrity - and I assuma this is true of all those who continue in charge.

But there are now some searching questions that need to be answered. I, therefore, would lika to see the CIA restored to its original assignment as the intelligence arm of the president and that whatever else it . can properly perform in that special field - and that its operational duties be terminated or properly used elsewhere.

We have grown up as a nation, respected for our free institutions and for our ability to maintain a free and open society. There is something about? the way the CIA has been functioning that is easting a shadow over our historic position and I
