MEMORANDUM FOR: DEPUTY DIRECTOR (INTELLIGENCE)

SUBJECT:

Operational Intelligence Support for the Office of International Trade, Commerce Department

1. PROBLEM:

a. To improve the Agency's intelligence support for OIT Commerce in the pursuance of its responsibility for export control and for preventing insofar as possible non-US export to the USSR and satellites.

2. DISCUSSION:

Previous Arrangements: In June of 1951 the responsibility for strategic intelligence support for OIT Commerce was placed on ORR. Responsibility for the transmittal of data collected by OSO and 00

- c. The Commerce Department has, however, on several occasions indicated to our representative on the Export Control Committees a feeling that intelligence which might be useful in operational decisions is not reaching OIT in time to be useful and has prepared a list of criteria for screening and transmitting to OIT Intelligence Division raw information collected by the Agency (TAB A). ORR believes this is a legitimate request. It should also be noted that collated material in the form of intelligence reports and memoranda which deal with the type of material indicated in TAB A are desired and in fact, have to some extent been provided by ORR.
- d. ORR will continue to be responsible within CIA for the development, analysis and evaluation of economic strategic intelligence through SECRET classification for OIT. ORR will also continue to represent CIA on various interdepartmental committees which advise the Secretary of Commerce in the field of export controls and to contribute intelligence support. Memoranda produced or correlated by ORR are transmitted, in accordance with regulations, directly by its representatives (or via OCD channels), to cleared officials of OIT, or presented in committees on which CIA is represented. ORR collaborates with OSI and OCI in development

of intelligence of primary concern to those offices.

3. RECOMMENDATIONS:

- a. OSO will be responsible for the selection of all SO material to be disseminated to OIT via OCD with the understanding that all clearances have been given by SO. OCD in addition will read all other SO reports against OIT requirements and release to OIT after clearance approval by SO. SO will transmit direct to OIT urgent operational SO information.
- b. OCD will be responsible for scanning all 00 material on the basis of requirements submitted by OIT (TAB A). Clearance will then be sought of 00 by OCD for those reports selected as being of interest to OIT; if such clearance is obtained, 00 will sanitize each particular report (by deleting source information, as necessary) and forward the sanitized version to ORR for information and comment as appropriate prior to transmittal by OCD to OIT.
- c. Material transmitted to OIT will be forwarded under security guidance of I&S.
- d. If the foregoing is approved these arrangements should be formalized by the interchange of the draft memos in TAB B. ORR would immediately discuss the draft with OIT.

Criteria for Selection of Intelligence Enterial for Transmittal to Commercial Intelligence Pivision, OIT, Department of Commerce

- 1. Information relative to the actual, suspected or attempted illegal movement of U.S. origin strategic and abort supply commodities (as defined by the Department of Commerce Pasitive List of Commodities) or other U.S. origin commodities in actual, suspected or attempted vielestions of the Export Control Act of 1949, as smooded.
- Environt of strategie and short supply commodities from any friendly or secupied countries to the Soviet orbit including any data relative to intermediately parallel-export central discussions. Opecial emphasis should be given to information concerning this type of transaction where in U.S., nationals are involved in any sepecity, except in the countderation of CO reports.
- 3. Information relative to local export, import, financial, from trade come, and translit trade controls, policies, procedures and changes in all countries.
- 4. Information relative to trade, burter and other commercial agreements and/or negotiations between mations with special emphasis on those between Western erbit and Soviet orbit countries, and with special emphasis on the degree to which such agreements and/or negotiations would affect the administration of the Battle Act.
- 5. Information relative to the consument of vessels (registry, transfer, early, bunkerage, ships stores) and to part and free part sativities insofer as they relate to expert scatted (including the 7-1 and

- 7. Information relative to the management, principals, or sotivities of manes desceptic (except in the case of CO reports) or foreign firms (or individuals engaged in commerce) which engage in or an ampected of undesirable or questionable essential practices, or effect to or have sympathy with political ideologies considered inimical to the interests of the U.S., or are suspected of such adherence or greathy.

MEMORANDUM FOR: THE DIRECTOR

FROM: Commerce Department

- 1. The Commerce Department, through its Office of International Trade, has in the last several years been discharging its responsibility for export control on U. S. commodities destined for Soviet or the Soviet Orbit in consultation with the other interested agencies of the Government. It has established committees as a means of securing other agencies advice, and through the representation of CIA on these committees, has secured intelligence guidance which has been greatly appreciated. Your Agency has also provided intelligence reports which have been useful in connection with enforcement of our export control policy.
- 2. Experience has shown that in some cases the failure of this Agency to receive raw intelligence information promptly has made it impossible to engage in certain actions which would strengthen our export control. It would be appreciated, therefore, if CIA would make available raw information reports which it receives of the nature set forth in the attached statement. It is understood, of course, that it may be necessary to make certain arrangements to protect the security of sources.
