1. The attached request from [redacted] 25X1X7
will require IAC action. Suggest comment to OCD along the following
lines:

25X1X7 This Office interposes no objection to the dissemination
to [redacted] of uncontrolled NIS
elements on the Pacific, Far East, and Southeast Asian countries.
However, authorization for such dissemination must, of course,
be obtained from the IAC pursuant to IAC-D-45/2 dated 31 March
1952.

With respect to the areas involved in [redacted] request, 25X1X7
attention is invited to the fact that [redacted] is now 25X1X7
receiving NIS on certain specifically designated countries within
the general areas in which [redacted] has indicated an interest. 25X1X7
25X1X7 [redacted] have fixed responsibilities to [redacted] for 25X1X7
the countries on which they receive the NIS, and it is believed
25X1X7 that [redacted] area interests are the same as those of the
25X1X7 [redacted] Accordingly, it is recommended that the general
areas designated by [redacted] be 25X1X7
25X1X7 considered as covering only those NIS areas for which dissemination
of NIS to [redacted] has been authorized. These NIS areas are
as follows:

- Borneo Part of British Indonesia, NIS No. 44
- Malaya Part of British Indonesia, NIS No. 44
- Burma NIS No. 38
- China NIS No. 39 (Including Formosa (IV),
Manchuria (II), Sinkiang (I), and

25X1X7 While it is not specifically stated, it is evident that [redacted] wishes to receive all
25X1X7 MIS which have been published on these areas to date, and
also receive additional elements on these areas, as and when
they are published. This will require an arrangement similar
to that which provides for dissemination of MIS to the
25X1X7 [redacted] which is set forth in IAC-D-45/12 (Revised), dated
21 July 1952.

There is attached, for your information, a list showing the
MIS elements that have been published on the above-listed areas,
and also the MIS elements now in process in D/B, and those
scheduled for production during the current fiscal year. The
published MIS elements and those in process in D/B have not
been controlled, but the producing agencies may place a control
statement on some of the elements scheduled for production in
this fiscal year, which would preclude dissemination of these
elements to foreign governments.
