- l. Since the procedure whereby the Deputy Director (Administration) approves of the accountings of Semior Representatives was established prior to the reorganization of last Summer, I have asked the Comptroller to look into this matter and determine whether it would not be more appropriate for the Deputy Director (Plans) to approve of these accountings in view of his over-all responsibility for the clandestine services.
- 2. Told Ed Saunders that as a result of my attendance at meeting with his Administrative Officers I had gotten a definite impression that it was the general opinion that the Finance Division could render much better service than it was rendering at the present time.
- 3.
