1. At the Executive Committee Meeting this morning:

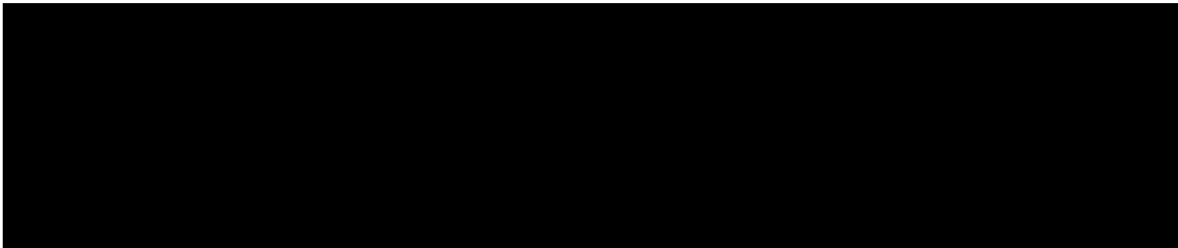
a. I advised the Director that the National Security Agency has requested briefings on our entire personnel procedures and that these briefings would take place within the next few days.

2. Emmett Echols advised me that the recruiters feel very strongly that it would be highly desirable to change JOT to COT. I asked him to get together with me soon to support this thesis since I want to make a decision on this matter rather promptly. H

3. John Tietjen plans to be on leave on 20 August, at which time he is scheduled to address the DD/I Supervisory Responsibilities Course. I told him that he could either have someone else make the talk or we would pay his transportation expense to and from his leave point if he wanted to make it himself.

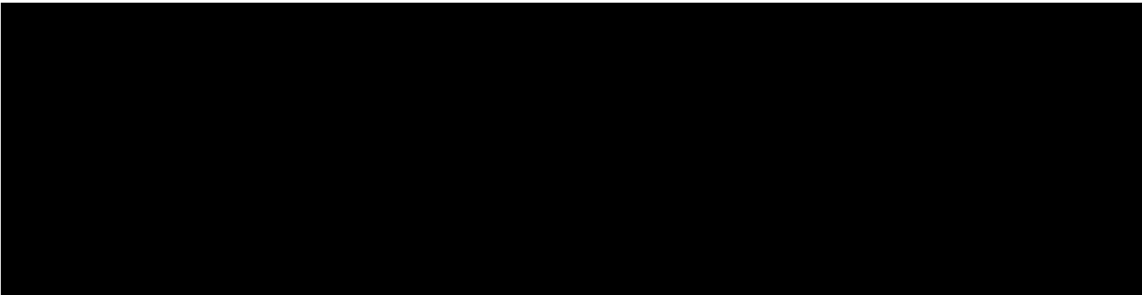
