25X1 5. [redacted] Received a call from Andrew Mayer,  
25X1 Congressional Research Service, Library of Congress, who said that, in  
25X1 connection with a study [redacted] his staff was doing, the quest  
25X1 of location of certain kinds of intelligence installations had arisen. After  
25X1 checking with [redacted] Congressional Support Officer, OCI, I called  
Mayer back and told him that these locations were very sensitive and had to  
be protected from public disclosure. Mayer understood perfectly and appre-  
ciated our effort to assist him.

25X1 6. [redacted] Donna Larsen, Secretary to Jack Marsh,  
25X1 Counsellor to the President, called and said the U-2 transcripts were  
25X1 still in General Scowcroft's office. They did not realize the length of  
25X1 the project but are working on them as fast as they can. She said she  
will let me know when they are finished.

25X1 7. [redacted] David Martin, Senate Internal Security  
25X1 Subcommittee staff, called and asked for a computer printout of the activities  
25X1 of [redacted] any substantive information on any of his activities, a list  
25X1 of any U. S. Communist Party delegations that have gone to Communist  
25X1 meetings outside the U. S., and anything on International Communist  
25X1 Conferences. [redacted] is checking this out.

25X1 8. [redacted] Called Bill Hogan, House Armed Services  
25X1 Committee staff, and advised him that the story in today's New York Times  
25X1 concerning the hiring of Mitchell Rogovin. I said the arrangement is in fact  
25X1 a contract with the firm for the services of Rogovin. I said for his private  
25X1 information he will get a salary not in excess of the Government ceiling.  
25X1 He said he felt hiring Rogovin will probably be helpful, although we will probably  
25X1 get some initial flack. Hogan asked about the staff memorandum that was  
25X1 mentioned in today's papers concerning Mr. Colby and the Rockefeller  
25X1 Commission. I said I didn't know the story on that but that the Commission  
25X1 did say in their report that overall they thought it was best to have a non-  
25X1 career man in the top job. I added they also thought that some part of the  
25X1 budget should be made public. Hogan felt this was terrible. He said as a  
25X1 matter of fact it probably is a blessing during these difficult days to have a  
25X1 career man who can understand the situation better. I heartily agreed.

25X1 9. [redacted] Acting on an alert from Messrs. Blake and  
25X1 Knoche, I contacted Jack Boos and Searle Field of the House Select Committee  
25X1 staff regarding the presence of a Committee investigator [redacted]  
25X1 offices (see Memorandum for the Record).
