- (b) Agreed that OCB has a continuing responsibility within policies approved in the NSC for developing courses of action to counter these Soviet Bloc activities in areas where national security policies have been assigned to OCB.
- (c) Agreed that the working group currently preparing an Outline Plan of Operations for Indonesia should give particular attention to actions designed to counter Bloc economic activities in that country and that the group, if required, should request assistance from any government agencies not now represented thereon.
- (d) Agreed that arrangements would be made, if possible, for a presentation at the next meeting of the Board Assistants of the status of current responsibilities and activities of various government agencies and interdepartmental bodies, including CFEP, concerned with the Sino-Soviet economic offensive.

- (3) Progress Report on the Near East (NSC 5428) Agreed that it would be desirable for the working group to proceed with the drafting of this report as the members! workloads permit and that the group should recommend a new date for submitting the report to the Executive Officer.

(d) Briefing on Fleet Capabilities

Enthusiastically accepted the invitation extended to the NSC Planning Board and the OCB Assistants by the Defense Board Assistant on behalf of the Navy Department to go to Norfolk for a briefing on fleet capabilities to be given abroad a carrier.
