Licenciado Carlos José GUTIERREZ Gutiérrez is a young attorney-at-law who has been a member of the local bar for four years. Mr. Ricardo FERNANDEZ Palma is the Chief Official of the Ministry of Economy and Finance. Mr. Manuel Antonio FERNANDEZ is a local high school teacher.

The Official Gazette for September 10, 1953 contains the appointment of Mr. Raúl TREJOS Flores, a younger brother of Lic. Eladio Trejos, as stenographer of the Permanent Delegation of Costa Rica to the United Nations. He is an attorney-at-law who was admitted to the local bar in 1950. According to his elder brother, Mr. Raúl Trejos is slated to eventually become permanent representative of Costa Rica in lieu of Rubén ESQUIVEL de la Guardia.
