## Enrollment and Physical Environment

1. With the large increase in the LTS enrollments for FY 1967-68, the practice of one-to-one student-teacher ratios must be discontinued if the School is to handle the increased enrollments without staff increases. No full-time classes should start that are less than five students.

Established new pattern for handling classes using not less than four students for common languages, three students for

The revised recommendation was applied to the extent possible, but spotty compliance with the policy and, lately, postponement of CT training has made this goal unattainable for the time being.

2. Start all full-time classes in March, July and November only.

To be implemented for CT's.

C/LTS comment on Action to Date:

The final CT schedule required six startings per year rather than three. Schedules were published in OTR Bulletin including 2 dates only for beginning part-time classes.

System had begun to show some results when IG report forced changes in CT schedule.

3. If LTS remains in its present quarters the building should be redesigned for school use, especially the ventilation system.

Work has been done on the interior of the building and the air conditioning system.

Work has been done slowly on interior of building. We can see no improvement in air conditioning system.
