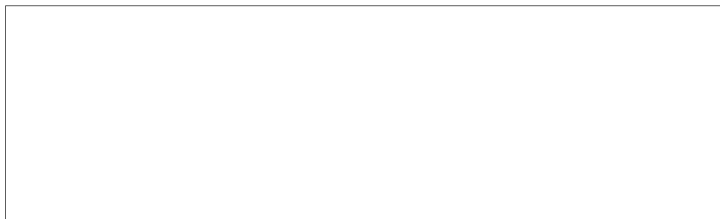

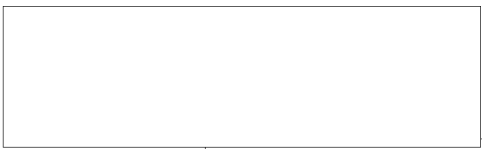

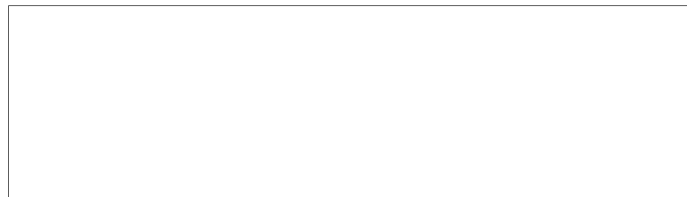

Gentlemen:

Reference is made to Task Order No. 3 which is, in turn, subject to the terms and conditions of our basic Contract No. RD-103.

By this Supplement, the Scope of Work, as set forth in the Schedule of Task Order No. 3, is amended in accordance with Contractor's letter proposal [redacted] dated 10 June 1958, and Exhibits submitted therewith relative to (Item 5) additional AG-6 Base Station Facilities. The aforesaid specifications are incorporated herein by reference and made a part hereof.

The estimated cost of performing this Task Order, as amended, exclusive of the fixed fee, is increased in the amount of Fifty-Six Thousand Three Hundred Twenty-Eight Dollars and No Cents (\$56,328.00). The fixed fee payable to the Contractor for the performance of the work under this Task Order, as amended, is increased in the amount of Four Thousand Two Hundred Twenty-Five Dollars and No Cents (\$4,225.00).

As a result of the above, the new total estimated cost of performing this Task Order, as amended, exclusive of the fixed fee, shall be One Million Two Hundred Seventy-Three Thousand Six Hundred Seven Dollars and No Cents (\$1,273,607.00). Likewise, the total fixed fee for the performance of this Task Order, as amended, shall be Ninety-Five Thousand Five Hundred Twenty Dollars and Ninety-Three Cents (\$95,520.93).
