Gentlemen:

This letter constitutes authorization to perform an open-end services type of Task Order to cover Work Orders which may be placed with your organization during the period 15 November 1957 to and including 30 June 1958, subject to the terms and provisions of our current master contract No. RD-128.

Work Orders will be issued against this open-end services type of Task Order from time to time and will be definite as to the scope of the work to be performed, the period of performance, and the estimated cost plus the fixed fee therefor. Work Orders will be issued against this Task Order only during the period stipulated above; however, the work or completion of performance under a Work Order may extend beyond 30 June 1958.

The accumulative allowable costs and fixed fees for performing the Work Orders issued for which you are to be reimbursed shall not exceed Thirty-Five Thousand Dollars (\$35,000.00), without the prior written authorization of the Contracting Officer. The Thirty-Five Thousand Dollars (\$35,000.00) is estimated only and the Contracting Officer does not guarantee that the accumulated allowable costs and the fixed fees covered by the Work Orders that may be issued will total the estimate.

Each Work Order will bear its own security classification. The existence of this Task Order is in itself unclassified as far as Government interest is concerned except that the Government component as represented by the Contracting Officer signing this document shall be classified SECRET information and this knowledge must be restricted
