Reference is made to Task Order No. 3 which is, in turn, subject to the terms and conditions of base Contract No. RD-128.

By this Supplement, the third paragraph appearing on the first page of Task Order No. 3 is deleted in its entirety and the following paragraph is substituted therefor:

The accumulative allowable costs and fixed fees for performing the Work Orders issued for which you are to be reimbursed shall not exceed Sixty-Five Thousand Dollars and No Cents (\$65,000.00), without the prior written authorization from the Contracting Officer. The Sixty-Five Thousand Dollars and No Cents (\$65,000.00) is estimated only and the Contracting Officer does not guarantee that the accumulated allowable costs and the fixed fees covered by the Work Orders that may be issued will total the estimate.

All other terms and conditions shall remain as originally stipulated.
