SCOPE OF WORK:

The Contractor shall perform the following work:

Phase I - Develop and furnish a group of bandpass transistor broadband amplifiers of the frequency range and quantities indicated:

1. 50 - 90 mcs 5 each
2. 100 - 150 mcs 5 each
3. 50 - 250 mcs 10 each
4. 250 - 500 mcs 10 each
5. 600 - 700 mcs 5 each

The above phase shall be performed in accordance with Section I of [redacted] Proposal P-1150, dated June 7, 1960.

Phase II - Study, develop, and furnish two (2) final models of 500 mcs to 1000 mcs Transistor Amplifiers as outlined in Section II of [redacted] Proposal P-1150, dated June 7, 1960.
