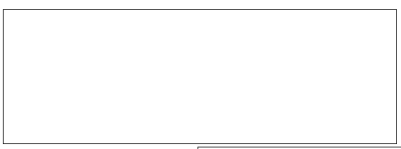

Gentlemen:

Reference is made to Task Order No. 6, as amended, which is, in turn, subject to the terms and provisions of Contract No. 605.

Pursuant to your letter of 30 September 1959, Task Order No. 6 is hereby further amended as follows:

1. In the Schedule under the paragraph entitled, "Scope of Work" the specifications are changed by deleting therefrom the requirement for 150 ohms impedance balance.
2. The estimated cost and fixed fee shown on page one (1) of the Task Order is changed to read as follows:

"The estimated cost of performing this Task Order, exclusive of the fixed fee, is Twenty-Eight Thousand Five Hundred Eighty-Five Dollars and No Cents (\$28,585.00). Costs in excess of this amount shall not be incurred without the prior written authorization of the Contracting Officer.

The fixed fee for the performance of this Task Order shall be Two Thousand Two Hundred Eighty-Seven Dollars and No Cents (\$2,287.00)."

All other terms and conditions of this Task Order shall remain unchanged.

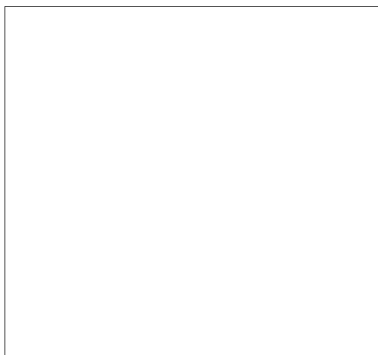
