Reference is made to Task Order No. 6, which is, in turn, subject to the terms and conditions of Contract No. 605.

Based upon your letter of 4 March 1960, which is incorporated herein by reference and made a part hereof, the estimated cost of performing this Task Order No. 6, as amended, is increased by an amount of Eleven Thousand Nine Hundred Sixty-Seven Dollars and No Cents (\$11,967.00) with no change in the fixed fee.

As a result of the above, the new total estimated cost for performing this Task Order No. 6, as amended, exclusive of the fixed fee, shall be Forty Thousand Five Hundred Fifty-Two Dollars and No Cents (\$40,552.00). The fixed fee shall remain Two Thousand Two Hundred Eighty-Seven Dollars and No Cents (\$2,287.00).
