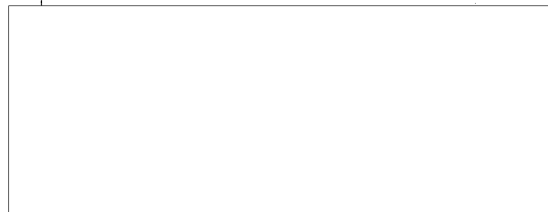
IDENTIFICATION PROJECT
