### I. TRAINING AND ROTATION STATUS REPORTS

The Secretary reported on the number of OCD personnel entered in various types of training since 16 November, and on the status of those participating in external training progrems or rotation assignments. See Tabs A, B, and C herewith.

### II. AFFLICATIONS FOR TRAINING

- a. The Board reviewed applications for the IBM Management Course at Endicott, New York and forwarded them to the Assistant Director recommending approval.
- b. Applications for the Air Weapons Course at Maxwell Field, Alabama were also considered by the Board. The Chairman emphasized the interest that OCD has in this course, and suggested that these and future applications should be placed on a slate arranged according to priority.
- c. The Board disapproved a request for language training during duty hours for an individual whose future CIA status is uncertain.

# III. REIMBURSEMENT FOR EXTERNAL TRAINING

The Board was informed by the Chairman that in the future, in accordance with a forthcoming memorandum from the Office of Training, reimbursement for external training will not be considered unless the request for training was submitted for approval prior to the commencement of the course.

The Chairman noted that the OTR memorandum was not intended to discourage individuals who have enough interest or initiative to take courses of instruction at their own time and expense.
