Lo The minutes of the third meeting of the CIA Carter Service Board, held 19 November 1952, were approved.

- 2. The Board approved the revision of Schedule A of the CIA Career Service Program (CIA Nobice dated 19 June 1552). This revision adds the Assistant Director for Communications as a permanent member of the Board. All of the live major chains of command in CIA are thus represented by permanent members. It also added to the list of those persons eligible to serve as rotating members, the five Chiera of the Senior Staffs in the MD/P organization, namely, the Chief, FI; the Chief, Po; the Chief, PM; the Chief, TS and the Chief, Administration. The revision also removed from the list two titles which had been abolished, 1.200 the AD/30 and the AD/PC. The Board agreed that of the two rotating members serving at any one time, one would always be cominated by the DD/I and one by the DD/P. The above changes would become a fective when approved
- 3. The Board agreed to recommend to the DCI that ir. Sherman Kent, AD/NE, be appointed as a member of the Board for the period 1 January 1953 through 30 June 1953 vice Mr. James M. Andrews, AD/CD wose term expired 3% December 1952.
- the The Chalkman reviewed the status of the proposed National Security Medal for which an Executive Order, covering regulations and a letter delegating to the DC authority for its award were on the desk of the President awaiting his signature. The Final Report of the Working Group

on Honor Awards, dated 9 January 1953, was approved by the Board with the amendment that the longevity awards program (Tab E) be implemented and administered by the AD/Personnel. The Chairman will present the Report to the DCI with the Board's recommendation that it be approved.

- So The Board considered the Interim Report of the Working Group on Regulation to implement the policy, previously approved in principle by the Board at its 2nd meeting on 17 October, entitled "Policy Concerning Additional Pay for Various Types of Mazardous Duty". Steps which had led to the preposed Regulation, some of the intangible factors concerning medication to work in CIA in general, the problems of hazardous duty pay in the Armed Services, the Secretary of Defense's civilian Commission on Escardous Duty and the impending conference in New York between and Rear Admiral Lewis L. Strauss, Chairman of that Commission were reviewed. The Board egreed to defer action on the Regulation until its next meeting and to request the individual Gareer Service Boards of the DD/P area to restudy the entire problem as well as the proposed Regulation and to make recommendations to the CIA Gareer Service Board at its next meeting.
- 6. The proposed CIA Regulation "Basic Intelligence Training", dated 23 December 1952, was approved in principle by the Board with the following according to
 - a. Paragraph B (5) "... all requests for exemptions shall be subject to the review and approval of the Mrector of Training, and where applicable to the provisions of C (1), (d) of this Regulation..."
 - b. Paragraph E (1) "... if the EOD date of such personnel does not permit direct processing into the Basic Intelligence Course, such personnel may be assigned to temporary duty in the sponsoring Office panding the beginning of the next Basic Intelligence Course if agreed upon by the Assistant Director of Personnel and the appropriate Office head...."
- 7. There was brief discussion of the "Summary of Career Service Activities for the period 15 August to 15 December 1952", dated 9 January 1953, with suggestions for minor modifications in the future.
- 8. Report was made of the status of the Commendatory Letters from the DOT to those CIA personnel who had served in support of U. S. intelligence for ten years or more. A revised and final copy of the report is attached.
- 9. The meeting was adjourned at 1655 to reconvens at the call of the Chairman.
